- A nonrefundable application fee of \$150 and a deposit of \$500 per person is due with the application to save your space.

FINAL PAYMENT:

- 50% of the remaining balance is due March 1, 2018 days after acceptance of your application however, we prefer full payment at this time if possible.

- All remaining balances are due May 9, 2018.

- Airfare is your responsibility except for the Delhi, India to Bhutan portion which is included, however, Airfare is subject to change until ticketed and tickets cannot be issued until payment is received.

- Deposits made on all Bhutan Flights are nonrefundable and nontransferable after March 5, 2018 due to the requirement to purchase nonrefundable and nontransferable airfares on limited flights to secure your spot on the trip.

AIRFARE: Airfare from Delhi/to home is not included in the trip cost. Please book your own flights. When you book your own flights, please be sure to arrive and depart in accordance with the times and dates LemonAid Fund Abroad suggests. This information will be provided to confirmed participants. Once you receive your final payment invoice, you should book your flights. If you are considering booking your flights before this time, contact us. We do not accept liability for cancellation penalties related to domestic or international airline tickets. Airfare is subject to change until ticketed and tickets cannot be issued until payment is received.

CANCELLATIONS:

All cancellations must be made in writing (via email) and be acknowledged by LemonAid Fund in writing (via email).

- Application Fee is nonrefundable and nontransferable



- The deposit is nonrefundable but may be applied to another trip within the same or next calendar year. Only one deposit transfer per trip/per deposit.
- Cancellations received from the time your application is received to 90 days prior to the trip start date are subject to full forfeiture of the deposit.
- Cancellations received between 90 and 60 days prior to the trip start date are subject to a cancellation fee equal to 50% of the total trip cost.
- Cancellations received within 60 days of the trip start date are subject to a cancellation fee equal to 100% of the entire tour cost.
- Any airfare paid is subject to separate terms and conditions which are provided upon ticketing. *If possible you may be able to transfer your spot to another participant if it is determined by LemonAid Fund Abroad that the other person is in the proper physical condition to participate in the trip activity and meets the requirements of the application process and assumes responsibility for any outstanding balance payments. This will be considered on a casebycase basis.*

INTERNATIONAL TRAVEL INSURANCE is required and details will be provided to confirmed participants.

INTERNATIONAL IMMUNIZATIONS MAY BE REQUIRED PER CDC and details will be provided to confirmed participants.

RESPONSIBILITY AND RELEASE STATEMENT

I acknowledge that the nature of the program may expose participant to hazards or risks that may result in participant's illness, personal injury or death and I understand and appreciate the nature of such hazards and risks and I accept all such risks.

LemonAid Fund its officers, employees and representatives are not liable to participant, participant's personal representatives, estate, heirs, next of kin for any and all claims and causes of action for loss of or damage to participant's property and for any and all illness or injury to participant's person, including his/her death, that may result from or occur during participant's participation in the program, whether caused by negligence of the LemonAid Fund its officers, employees, volunteers, representatives, or otherwise. I further agree to indemnify and hold harmless the LemonAid Fund, its officers, employees, and representatives from liability for the injury or death of any person(s) and damage to property that may result from participant's negligent or intentional act or omission while participating in the described program. I hereby agree that if participant's behavior during the program is such that they may cause harm to themselves or other participants, or is consistently impeding the enjoyment of the program for others, participant will be removed from the trip, at the discretion of the LemonAid Fund volunteers supporting the program, and sent home at the participant's sole expense and no refund will be due for any unused portion of the trip. LemonAid Fund assumes no liability for failure to provide the services outlined in the trip itinerary in the event that such services and accommodations cannot be supplied due to delays or other causes beyond the control of LemonAid Fund, which include but are not limited to sickness, epidemics, pandemics, weather, strike, war, civil disturbances, acts or threats of terrorism, travel warnings or bans, termination or suspension of war risks or other carrier insurance, quarantine, and acts of nature. LemonAid Fund reserves the right to cancel this trip prior to departure due to any of the aforesaid causes



beyond our control, in which case the passenger will receive a refund of as much advance tour payments paid by the LemonAid Fund participant as LemonAid Fund is able to recover on the passenger's behalf, but LemonAid Fund shall not have any obligation or liability to the LemonAid Fund participant beyond the foregoing. Participant does not have any physical or mental issues that will prevent them from participating fully in the program described throughout and agrees to adhere to all rules and expectations outlined.
